- A** Tavern License-Sale of liquor, wine, or beer on or off licensed premises, including package sales. \$400.00
- B** Restaurant or Lodging License - Sale of liquor, wine or beer, on or off licensed premises, including package sales. \$450.00
- C** Package License - Sale of liquor, wine or beer in the original package, off licensed premises. \$300.00
- D** Cabaret License - Sale of liquor, wine or beer, off or on licensed premises, including package sales, where such sales do not constitute the principal item of business. \$500.00
- E** Beer & Wine Only License - Sale of beer or wine in original package only, off premises, where the principal business is the sale of meats, groceries and related food products. \$250.00
- F** Beer Only License - Sale of beer in the original package only, off the licensed premises, where the principal business is the sale of merchandise other than beer which merchandise shall include groceries and related products. \$225.00
- G** Special Events License - Sale of liquor, wine or beer for period of time designated in said license, not to exceed seven (7) days. This license may be issued to persons to persons already having a license. \$30.00
- H** Sunday Sales - Shall be issued for a six month period only and shall be issued only to a licensee who is the holder of either a Class A, C, E or F license and shall permit sales during the hours hereinafter provided. Fee shall be \$200.00 for holders of Class A, \$150.00 for holders of Class C, \$125.00 for holders Class E, \$100.00 for holders of Class F. \$200.00

### Hours of Operation

- A. It shall be lawful for licensees holding Class A, C, E and F licenses to sell or offer for sale at retail alcoholic liquors only between the following hours:
- (1) From 6:00 AM on each Monday through Thursday until 1:00 AM on the following day.
  - (2) From 6:00 AM on each Friday and Saturday until 1:30 AM on the following day.
- B. It shall be lawful for licensees holding Class B & D licenses to sell or offer for sale at retail alcoholic liquors only between the following hours:
- (1) From 11:00 AM on each Monday through Thursday until 1:00 AM on the following day.
  - (2) From 11:00 AM on each Friday and Saturday until 1:30 AM on the following day.
  - (3) From 11:00 AM on each Sunday until 1:00 AM on Monday.
- C. Licensees holding Class G licenses may sell alcoholic liquors on the days and during the hours prescribed in the license issued to the holder thereof.
- D. On New Year's Eve licensees holding Class A, B, C, D, E and F licenses may continue the sale of alcoholic liquors until 2:00 AM on the following morning.
